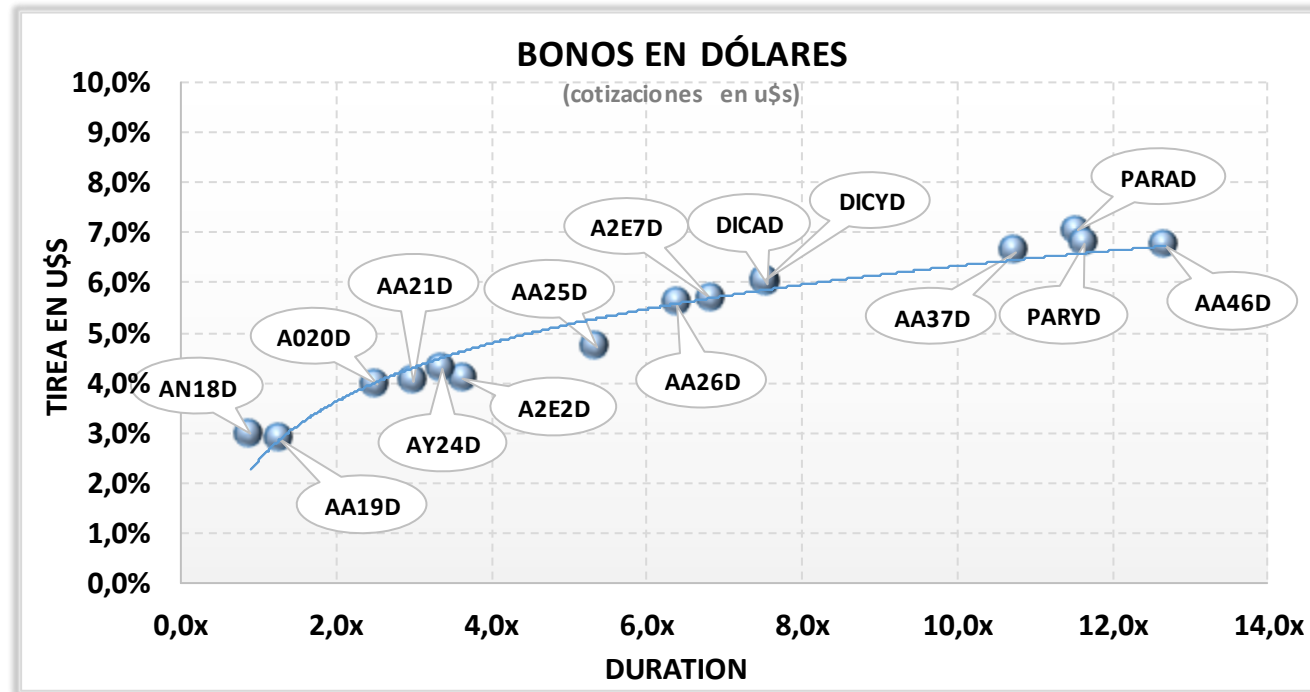

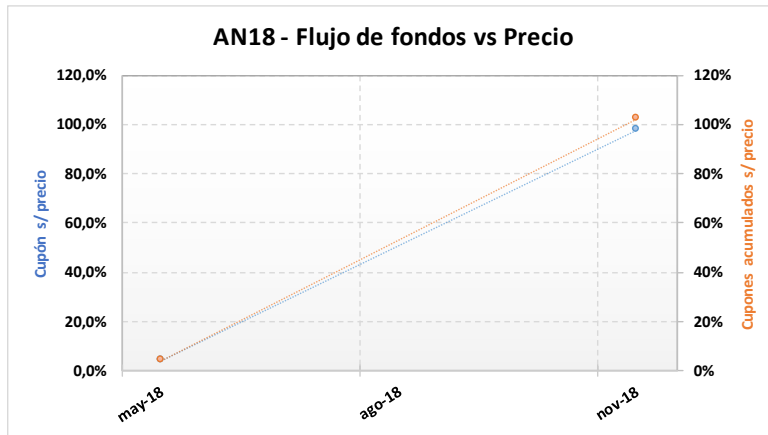

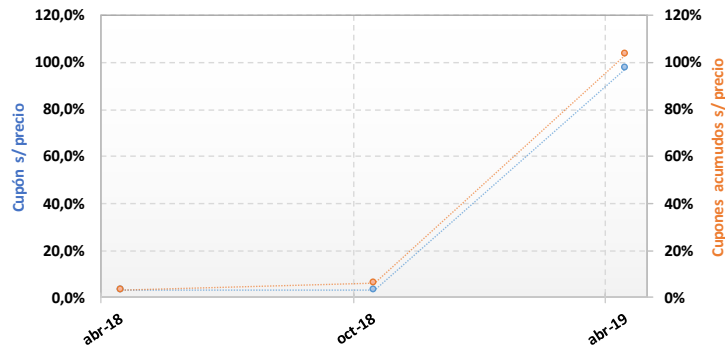

AA19 - Flujo de fondos vs Precio



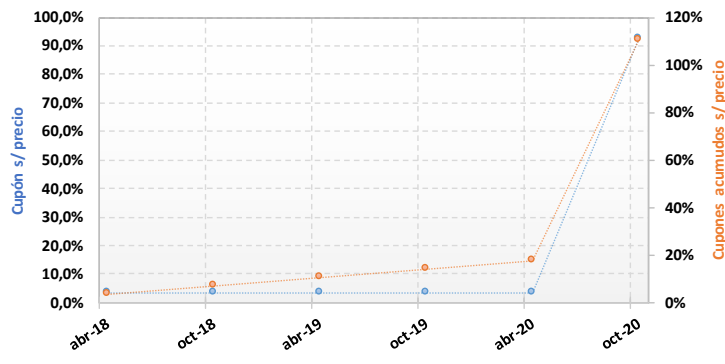

AO20 - Flujo de fondos vs Precio



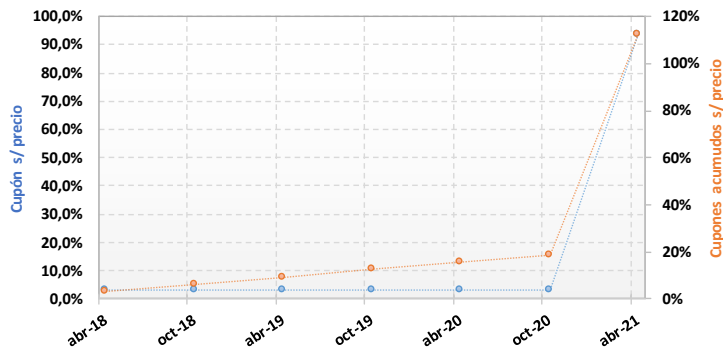

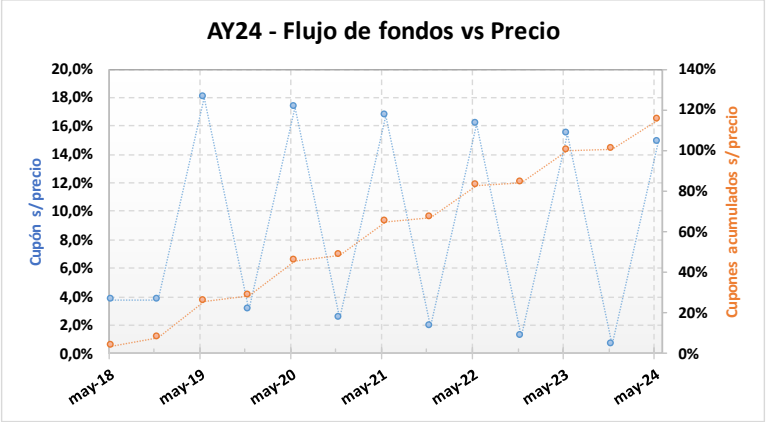

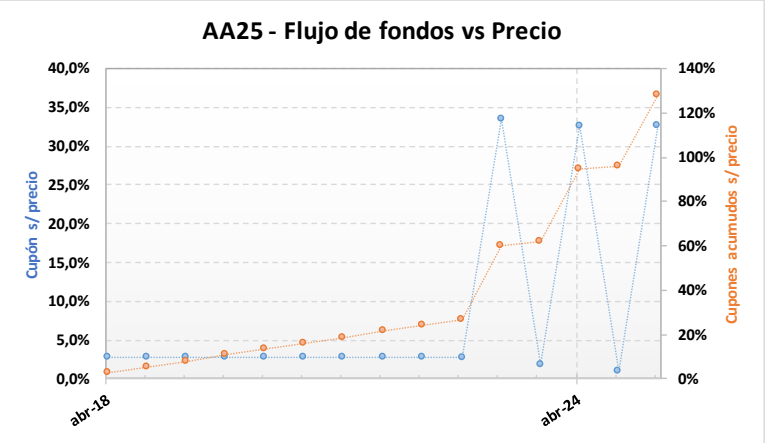

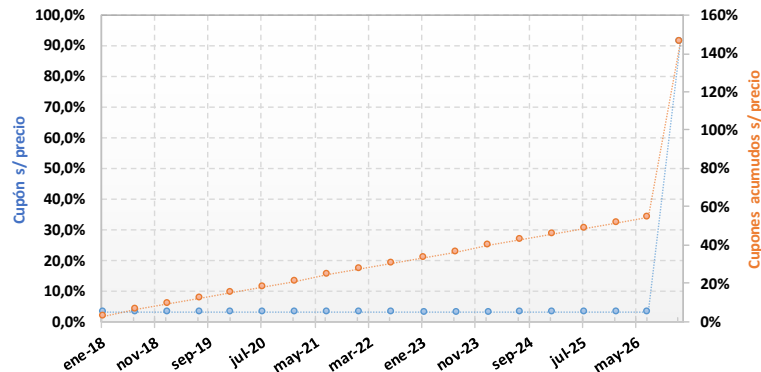

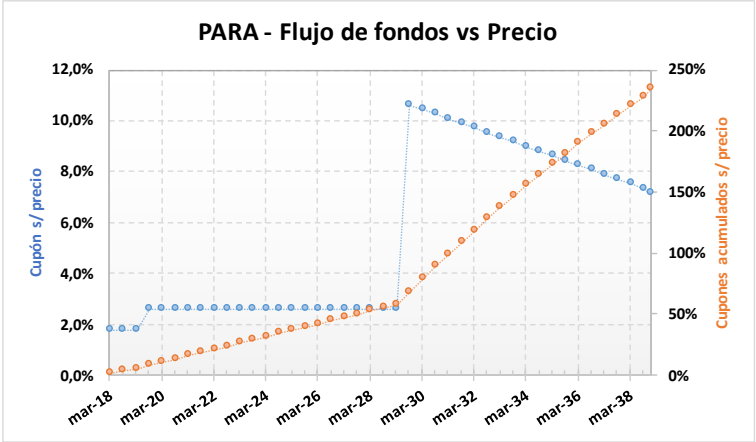

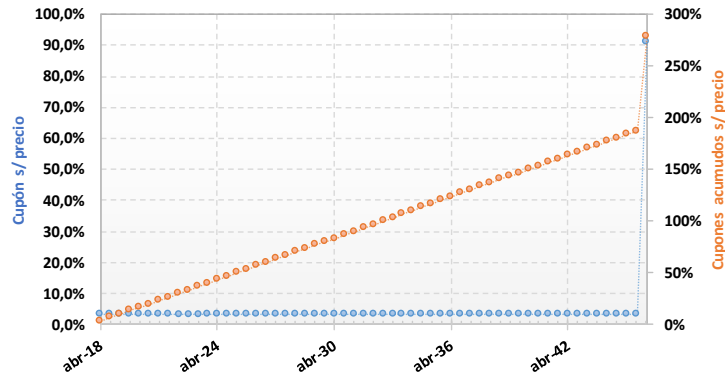
