AO20 - Flujo de fondos vs Precio



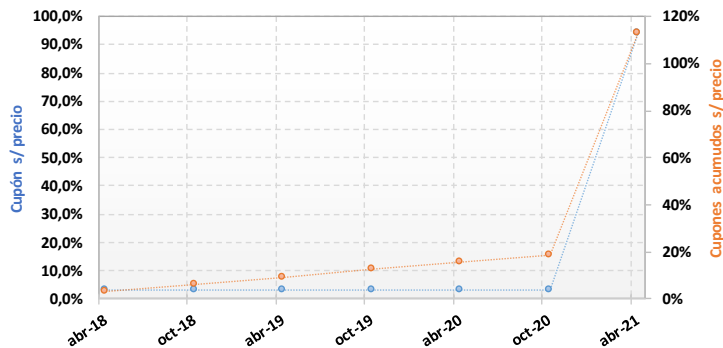

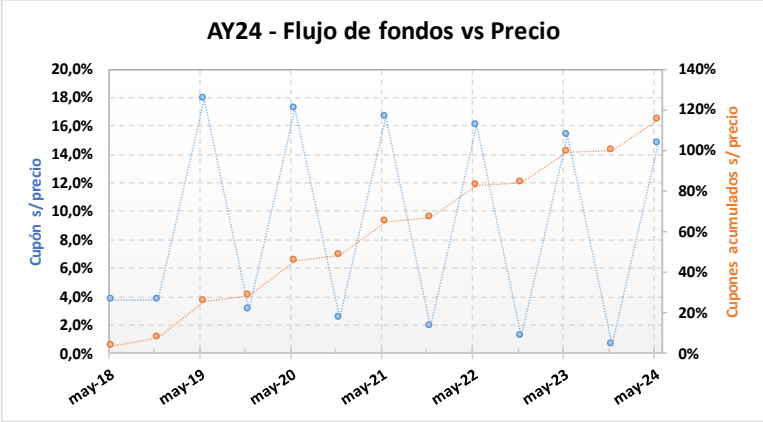

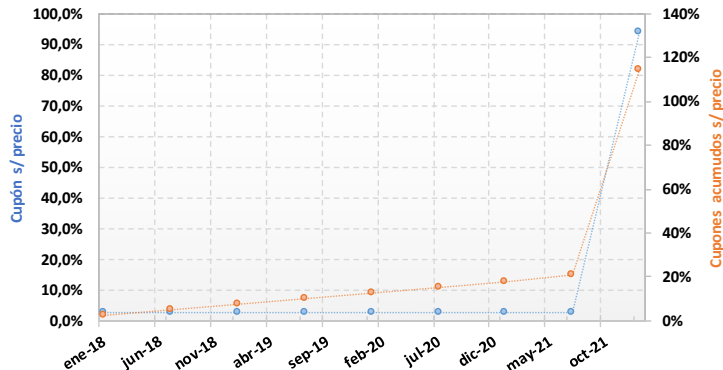

A2E2 - Flujo de fondos vs Precio



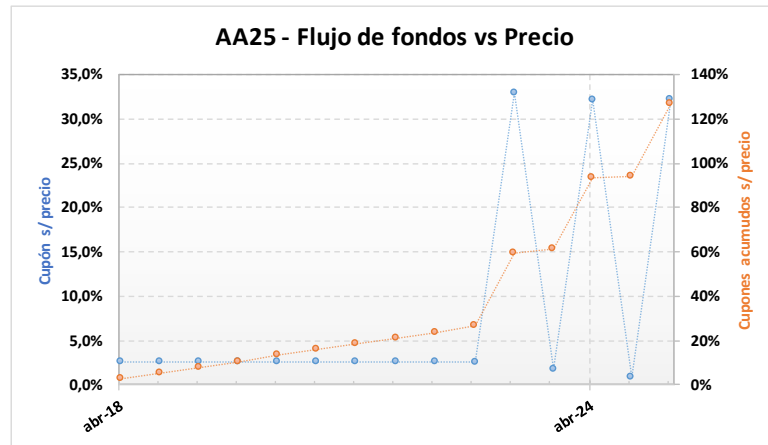

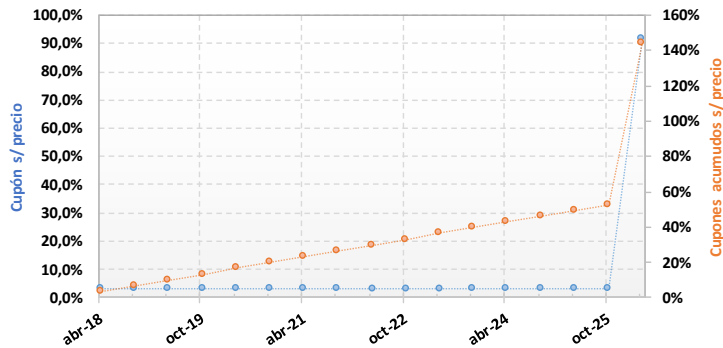

AA26 - Flujo de fondos vs Precio



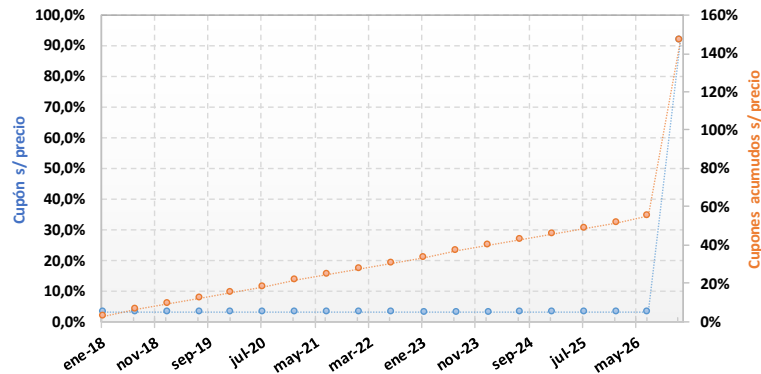

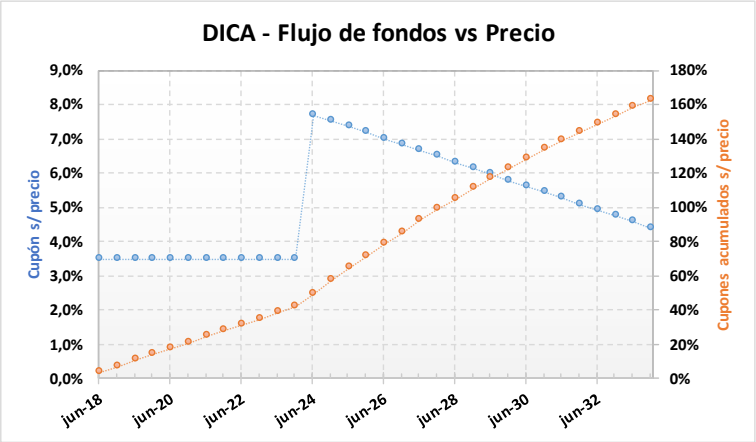

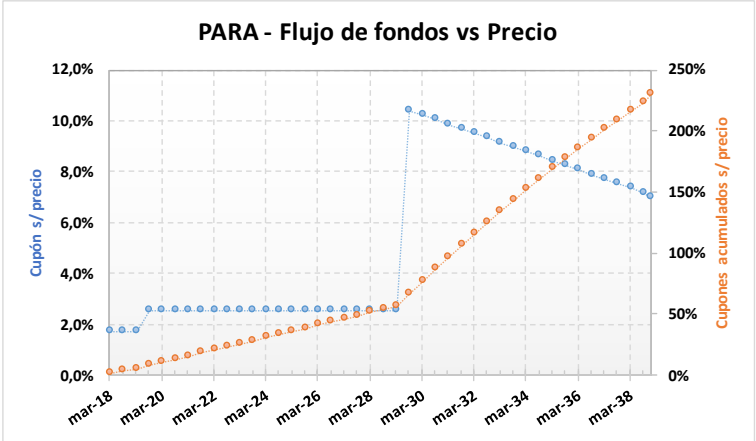

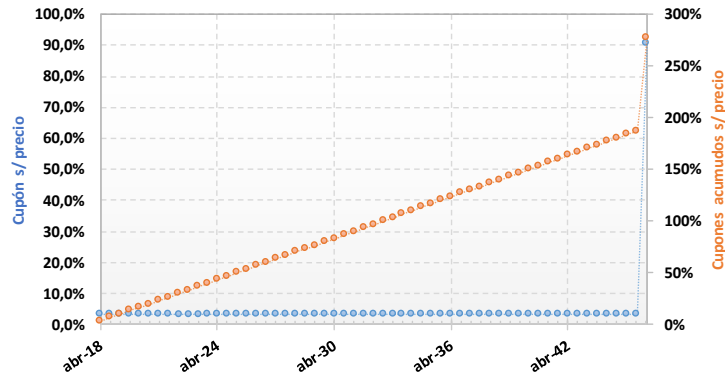
