A2E7 - Flujo de fondos vs Precio



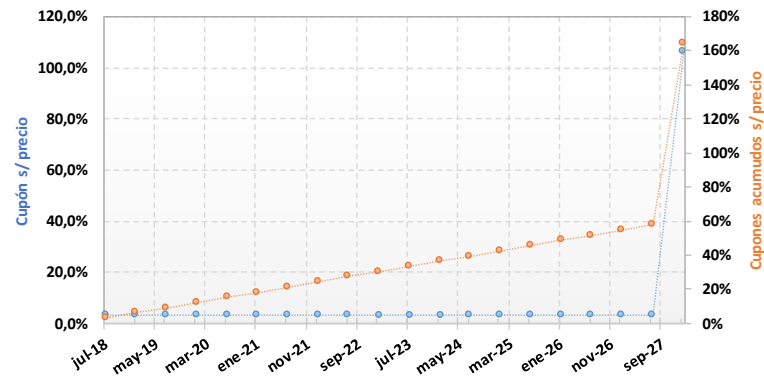

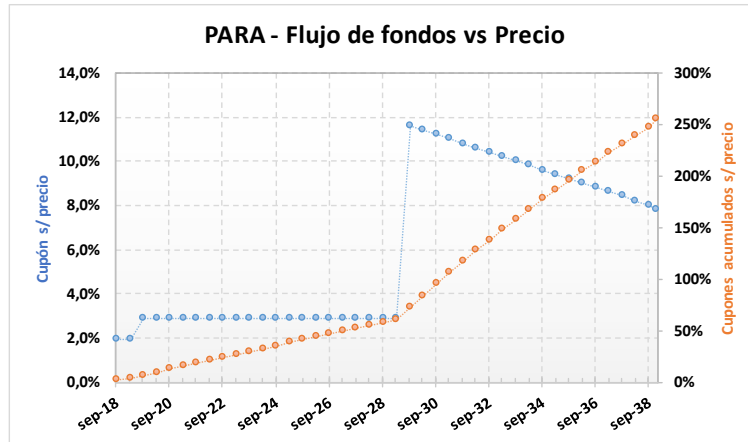
