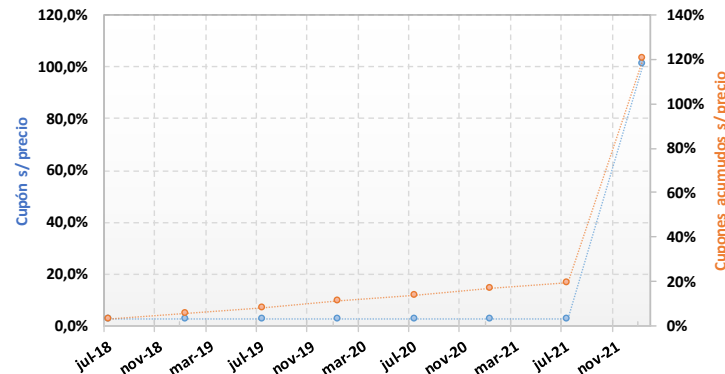

A2E2 - Flujo de fondos vs Precio



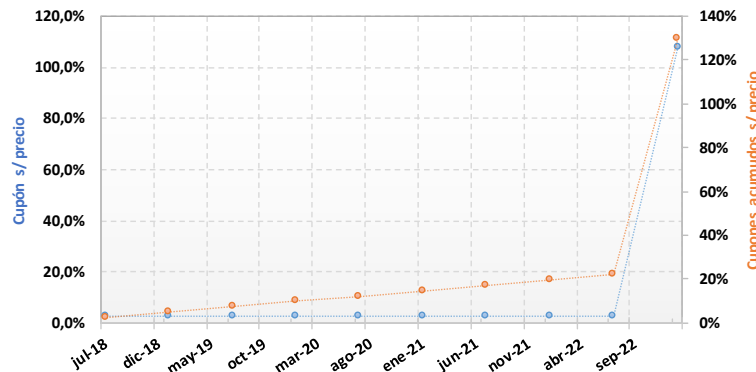

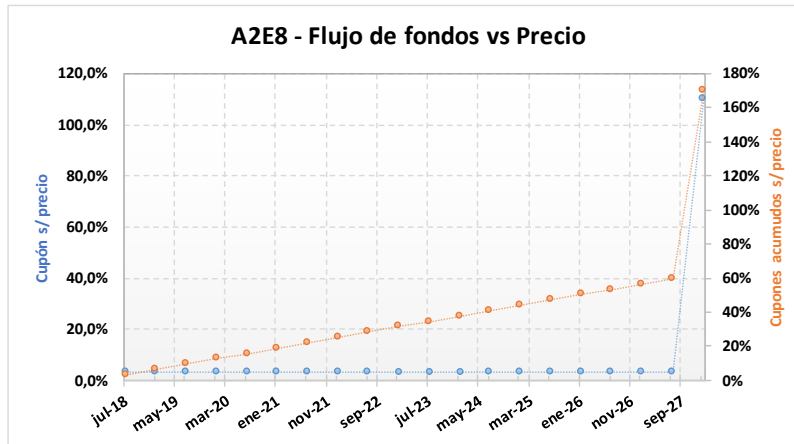

AE48 - Flujo de fondos vs Precio



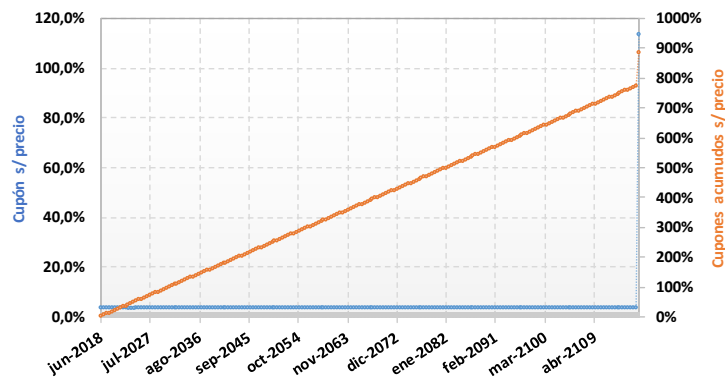
